Bell & Hart's 8 causes of conflict: Bell (2002) suggested six key reasons for conflict occurring in the workplace and in 2009 Hart added two more. These 8 causes are generally assumed to be the main reasons conflict can occur in an organisation and we have looked at them in more detail below.
